Adopt Agenda

Mr. Penovi moved to adopt agenda. Motion was seconded by Mr. Burns and unanimously approved.

Approve minutes from October 12th meeting

Mr. Burns moved to approve these minutes, Mr. Penovi seconded, and it was unanimously approved.

Financial audit update from Mauldin & Jenkins

Mr. Moses presented an update on the financial audit and stated that the audit is close to being completed.
